## **Policy Council Report**

May 16, 2024 Policy Council Meeting Report

- 1. The hire request of Mercedes Gonzales as an On-Call Teacher Assistant was approved.
- 2. The One-Time Funding Request for 16 window replacements in Head Start/Early Head Start classrooms was approved.
- 3. The 2024 COLA of 2.35% was approved.
- 4. The April 18, 2024 Policy Council Meeting Minutes were approved.
- 5. The April 29, 2024 Interim Policy Council Meeting Minutes were approved.
- 6. The Program Workplans (Program Governance, Financial & Administrative, ERSEA, EHS Centerbased, PHS Centerbased, Disabilities, Mental Health, EHS, Homebased, Family Development, Health & Pregnant Women) were reviewed.
- 7. Active Supervision Assessment Updates were given.
- 8. Program Performance Report:
  - Everything is going well. No milestones, due dates or requirements have been missed.
  - Beginning to work on our PIR (Program Information Report) which takes a few months to complete and includes the entire year

- 9. Budget Committee/Fiscal Report:
  - 2024-2025 Fiscal Year is approximately 25% complete as of 4/30/24
  - Staff were asked to contact Fiscal Office with questions once budget reports are received and reviewed
  - Beginning the process for Utah and Idaho CACFP renewals for 2024-2025 service year
  - 2023-2024 SEP distribution is currently estimated at 7-8%
    - Actual numbers are dependent on closing the 2023-2024 Fiscal Year and a final review by the Fiscal Officer
  - Annual TANF review with Bill Foxcroft was on 4/22/2024
    - We passed the review and are in good standing with TANF
    - TANF grant year end is approaching (6/30/2024)
      - We don't anticipate needing to spend down any funds
      - Next grant amount from TANF is expected to marginally increase
  - Annual Fiscal Audit is scheduled for June 2024 which includes the audit of ERSEA eligibility requirements
    - The Audit will be presented at the August Board Meeting
    - o A copy of the audit will be sent to Policy Council as information only
  - Year-end administration cost percentage calculation was completed
    - As per grant awards, this cost cannot account for more than 15% of total spending
    - o The results were PHS: 9% and EHS: 9%
  - Goal is to have the 2023-2024 Fiscal Year closed by the end of May
  - The COLA grant application was automatically processed by Head Start this year
    - Grant award was increased to \$205,928 (\$124,573 for HS and \$81,355 for EHS)
       to accommodate the 2.35% COLA increase
      - No need to apply for the COLA funding this year but the increase will need to be approved by Policy Council and Board
  - Policy Council inquired why there is a limit on the income to enroll families. They do not want anyone to get left behind.
    - When Head Start was first developed in the early 60', the specifically wanted a
      preschool program form families that fall within certain income ranges.
       Congress gives out the funding. The thought is that children who fall within a
      certain income range will always have preschool services.
    - We received one of the first Early Head Start grants (for children ages 0-3) in the 1990's.
    - We understand there are many others who could benefit from Head Start programs, but because of the way it is funded, it is designed to benefit the ones who need it most first. We are then allowed to enroll up to 10% of over income children.
    - We are allowed to enroll 35% of our slots with children whose family income falls within 100-130% of poverty
    - We have selection criteria from the Performance Standards that also allow us to place children with the highest needs at the top of our waitlists
      - Certain cities within our service areas, such as Paris and Montpelier,
         Idaho are tricky because incomes are higher as well as housing costs
      - Some areas do not have as many resources

- We use TANF funding in areas like Paris to be able to enroll children who are considered over income
- According to the McKinney Vento Act the legal definition of homelessness includes multiple families living in the same home, families living in temporary housing or unsafe housing. There are criteria to qualify as homeless and every situation is considered case-by-case.
